6. The technical bids were evaluated and cross checked by the team of Drug Inspectors deputed for this purpose by the Health Department. The evaluation sheets were uploaded on the official website of the BMSICL for claims/objection/clarification if any upto 25.07.2018. The claims/objections/clarification thus received were again evaluated and a comparative chart was prepared by the team of the deputed Drug Inspectors. The Technical Evaluation Committee in its meeting dated 31.07.2018 perused the evaluation sheets as well as the comparative chart and recorded its finding in the minutes of the meeting and recommended for factory inspection of the technically qualified bidders. Accordingly factory inspection was done by the teams of Drug Inspectors deployed for its purpose.

7. After comparison of the Factory Inspection report submitted by the team of Drug Inspectors the drug wise technical evaluation findings were recorded as follows by the Technical Evaluation Committee in its meeting dated 24.08.2018.
